CONSEQUENCES OF JOE BIDEN'S BORDER CRISIS

Overview

A renewed focus must be directed towards the porous southern and northern American borders amidst growing unrest following the Hamas-led invasion of Israel that killed 1,300 Israelis and wounded thousands more. The threat that Hamas members or those tied to terrorists organizations crossing the border into the U.S. is real, as Customs and Border Protection (CBP) have issued a new memo warning its field offices to be on the lookout for "terror-tied individuals" entering via the southern border.

The country's porous borders have made it easier for terrorists to enter the U.S. In fiscal year 2023, a growing number of people encountered at the southern and northern border appear on the FBI's terrorist watchlist. Making matters worse, encounters with migrants from the Eastern Hemisphere (the Middle East and Africa) have more than doubled this past year to 228,000. Migrants from the Eastern hemisphere further exacerbate the country's security challenges as they require additional vetting and its more difficult to deport them.

This doesn't account for the people who have evaded detection and entered the country illegally. So far this month, 19 Iranians, 17 Syrians and two Lebanese men deemed "special interest aliens" have been apprehended at the border. It is unclear if they have ties to terrorist groups as the Biden administration has kept this important information classified.

As illegal border crossings have hit a record and over 2 million migrants apprehended in 2023, focus should be directed towards the people who have slipped undetected through the border. Under Biden, 1.5 million people, referred to as "gotaways," managed to evade agents and enter the country illegally. This month alone, more than 18,000 people have entered the country.

Lately, enough fentanyl to kill the entire U.S. population has been seized at the border which according to sources, may only be about 10 to 15 percent of what is actually coming over the border. Illegal fentanyl is responsible for the leading cause of death for Americans aged 18 to 49, now claiming more lives than car accidents, guns or suicide.

As American's have witnessed the brutal result of Israel's compromised border, Biden's new border crisis will continue to pose a risk to the safety and security of U.S. citizens.
